2011 – 2012 STUDENT DRIVING / PARKING REGULATIONS

Students will be required to register their cars and be assigned a parking space on the northeast and northwest sides of the building. Students driving their vehicle to school are required to purchase a parking permit tag and display the tag on their rearview mirror daily. Students are not to park in employee parking areas during the school day. Students are also expected to abide by the following regulations:

1. Reckless driving will not be tolerated.
2. Students are to vacate cars immediately upon arrival and are not to sit in them during lunch or school hours.
3. Roadside parking is prohibited.
4. All cars must use the proper entrance and exit drives to the school.
5. Parking in grass areas or driving through unpaved areas is prohibited.
6. After school, students should not leave the parking lot while the buses are in motion.
7. Students are required to park in their assigned space in the designated student parking areas during the school day.
8. Students are not to transport other students skipping class or violating other school rules.

Students who violate any parking regulations will be subject to assignment of the disciplinary consequences of Saturday Detention, Out of School Suspension, and/or 30 days of Driving Suspension.

NO PARKING PERMIT WILL BE ISSUED ON AUGUST 17th UNLESS THE STUDENT HAS ACCURATELY COMPLETED A PARKING PERMIT REQUEST FORM AND PAID THE PARKING FEE.
